CALENDARS

A robust [calendar management system](#) is crucial to keep your clients up-to-date on what's going on with their divorce and to keep you on deadlines. Use calendar invites for any ongoing meetings with your team about your client's case so that everyone's on the same page. Set up recurring reminders in your calendar of upcoming deadlines for a client so that every necessary task, like filing divorce papers, is finished well before it's due.

You can also use your calendar to remind you to update clients on the status of their cases. Even include them in a meeting if you'd like, or put them on the invite, so they know their needs are being addressed. TASK MANAGEMENT

A robust task management system that works in tandem with your calendar helps you stay focused and on schedule. With task management features, you can assign tasks to specific team members so no one accidentally drops the ball on an important parenting plan because they think their co-worker is doing it. You can assign the parenting plan to the correct person directly, along with a due date so they see the item in their calendar.

This feature makes it easy to update clients as well. If they call with a question, the entire schedule for their case will be in your calendar. You can deliver an answer in minutes rather than trying to shuffle through documents or a paper calendar to figure out when a date's coming up or when important paperwork is due.

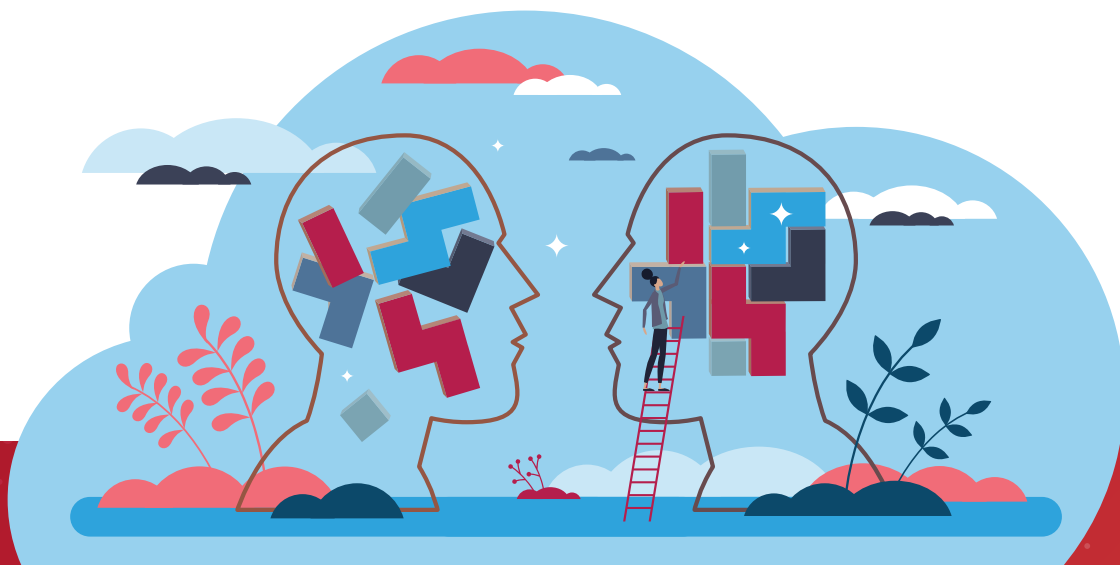

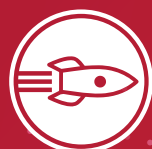
